 - Finished base profile and pitch
 - Paver installation and workmanship
- **Segmental Retaining Walls less than 4' in height:**
 - Footer / leveling pad width and depth of modified stone
 - Minimum block embedment below grade
 - Block core fill w/ clean stone (if required)
 - Installation of 4" perforated drainage pipe
 - Overall wall construction workmanship
 - Proper compaction of modified stone in footer
 - Proper block installation
 - Minimum of 12" clean stone drainage behind wall
 - Proper installation and use of adhesive for wall caps
- **Engineered Segmental Retaining Walls (walls 4' and higher):**
 - Inspection criteria as per Engineered Plan
- **Raised Patio Construction:**
 - Excavation and removal of all unsuitable soils and material
 - Suitable backfill material and compaction
 - Over dig stabilization inspection (if required)
 - Overall construction workmanship
 - Applicable SRW requirements
 - Applicable paver requirements
 - Step construction inspection (solid block, equal riser heights)

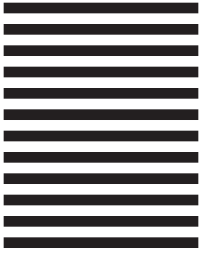
